Notice regarding option of appeal for medically unfit candidates of

After being shortlisted for Document Verification for the posts of **Junior Engineers** in **Level- 6** against CEN:03/2024 (Junior Engineers), the following candidates appeared for Document Verification in the office of Chairman, Railway Recruitment Board, Malda which was followed by Medical Examination at Divisional Railway Hospital, Malda.

However, as per medical report received from the Railway Hospital, Malda they were not fit in prescribed medical standard by the three member medical committee.

The procedure of appeal is as follows:

- (i) If any candidate wants to appeal against his/her above medical report, he/she should submit an appeal to the following authority within the period of one month from the date of issue of this notice with due justification.

(ii) Such an appeal shall be entertained, only if the candidate produces a medical certificate from a Government/ Private Doctor of the Specialist/ Specialities in which the candidate has been found Unfit. Such certificate should contain a note that “The Government/ Private Specialist is fully aware of the physical and visual standards set by the Railways for the particular medical category and that he/she is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate medical board comprising of three Senior Railway Doctors appointed by the Government in this regard.” The certificate should bear the photograph and marks of identifications of the candidate duly attested by such Government/ Private issuing authority shall also clearly mention his/her full name, designation, address, name of clinic with address, valid contact number, etc. and his/her Medical Council of India/ State registration Number. If any candidate wants to appeal against this medical verdict, he/ she may send his/ her appeal as indicated above to Railway Recruitment Board, Malda by **14/02/2026** with the following three documents.

- (a) Appeal with justifications duly signed by the candidate indicating his/her Roll No., Registration No. and date of Document Verification. **Proforma-B**
- (b) Medical certificate issued by Government/ Private Specialist as per the format enclosed as **Proforma-A.**
- (c) A Demand Draft for **Rs.1000/-** (Rupees one thousand only) in favour of **PFA & CAO, Eastern Railway, Kolkata.**


