The following important information is hereby notified for all **Provisionally Eligible** candidates appearing in the **Erstwhile Group 'D' (Level-1)** Examination under Scouts & Guides Quota (Open Advertisement) 2025–26. Candidates are advised to note the examination schedule and instructions carefully as mentioned below:

1. The Stage-I Examination for recruitment against Scouts & Guides Quota (Open Advertisement)/2025–26 for **Erstwhile Group 'D' (Level-1)** is scheduled to be held on **28/01/2026**.
2. The mode of examination will be **Computer Based Test (CBT)**. It may be noted that the CBT will consist of **40 Multiple Choice Questions (MCQs)** carrying **1 mark each** and **one (01) Essay-Type (Subjective) Question** carrying **20 marks**. The MCQs will be displayed on the computer interface and responses are to be submitted on the computer screen. The Essay-Type Question will also be displayed on the computer screen; however, the response is required to be written on the **physical answer sheet** provided during the examination.
3. A dedicated **Candidate Login link** for downloading the E-Call Letter and viewing all examination-related details will be made live from **14.01.2026 (10:00 Hrs.)** on the official website of RRC/ER.
4. Candidates are advised to regularly visit the official website, at least once a day of RRC/ER for updates.
5. The **Time, Venue and further Instructions** of the examination will be indicated in the E-Call Letter. Candidates must download their Call Letter through the link that will be made available on the official website of RRC/ER.
6. Candidates must carry the **E-Call Letter** and a valid **Photo Identity Proof** and **Four (4) recent passport-size photograph** to the examination venue. Entry without these documents may not be permitted.
7. **No separate E-Call Letter will be communicated to the candidates individually.** All updates will be available only on the official website of RRC/ER.
8. RRC/ER reserves the right to modify or reschedule the examination date, time, venue, or any other examination-related activity, as deemed necessary.
9. No request, representation, or correspondence from candidates for change of examination date, time, venue or any related matter shall be entertained.
10. No TA/DA, accommodation, travel facility, free ticket or pass will be provided to any candidate for appearing in the examination. Only SC/ST candidates will be eligible for *Free Travel Authority* as per extant Railway Board instructions.
