All candidates Provisionally Eligible for the Sports of Swimming (M), Swimming (W), Hockey (M), Cricket (M), Cricket (W), Basketball (W), Kabaddi (M), Kabaddi (W), Athletics (W), Volleyball (M), Volleyball (W) and Football (M) for trials for recruitment against Sports Quota (Open Advertisement) for the year 2025-26 are hereby informed that the details of DV & Trials for the above-mentioned disciplines are appended below. They are directed to go through the same. Eligible candidates may download E-Call letters from 21/01/2026 (16:00 Hrs.) onwards from the Notice Board section of RRC/ER/Kolkata's website i.e. www.rrcer.org. The instructions for trials as provided in the RRC/ER's Sports Quota Notification and E-Call letter are to be necessarily followed. Documents should necessarily be produced on the date and venue of DV & trials. **It may be noted that the Document Verification (DV) for some of the sports disciplines will be conducted one day prior to the field trials. Any candidate who fails to report for DV at the scheduled date, time, and venue will not be permitted to appear in the selection trials.** Candidates are advised that they may be required to stay for a period of 3–4 days for completion of DV and trials and, therefore, should make their own arrangements accordingly. No accommodation will be provided to the candidates by RRC/ER or the Railways.

Instructions to Provisionally Eligible candidates for selection trials for recruitment against Sports Quota (Open Advertisement) for the year 2025-26:

1. Candidates must bring their own playing kits and other sports equipment on the specified trials date at the specified venue and time.
2. **Candidates must reach the trial venue at least one hour before the scheduled time.**
3. Candidates must bring originals of all certificates in support of their claims pertaining to age, educational qualifications, sports qualification and community etc.
4. Candidates must bring one set of self-attested photocopies of all necessary certificates. They must also bring at least one photo ID proof viz. (Voter ID, Aadhar Card, PAN Card) and four (04) stamp size photographs which are identical to the one submitted with application form.
5. All certificates must be in the prescribed format as per the notification.
6. No request, whatsoever, shall be entertained in any circumstances for change of date, time and venue for Document Verification and the selection trials.
7. Candidates must follow all instructions mentioned in the sports quota notification and the e-call letter.
8. Besides, candidates must adhere to all instructions given by the Railway officials at the venue.
9. Any indiscipline, unfair practice, impersonation or discrepancy in the document, will immediately lead to cancellation of candidature.
10. RRC/er reserves the right to change the time, date and venue of the selection trials in administrative interest/exigencies.
