3. Application for the Appeal should be as per proforma- A (Enclosed) along with following enclosures.
- A certificate (in original) as per Proforma- B (Enclosed) from a Government/Private Doctor of the specialty/specialties in which the candidate has been found unfit. Such certificate should contain
 - a note that the Government / private specialist is fully aware of the physical and visual standards set by the Railways for the particular medical category, and that he is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate medical board.
 - Detailed diagnosis particulars (both with glass and without glass for visual standards
 - photograph and mark of identification of the candidates duly attested by such a government /private medical certificate issuing authority duly mentioning his/her MCI/State registration number.
 - A Demand Draft (DD) for amount Rs 1,000/- (Rupees One thousand only) in favor of Chairman / RRB/ Bangalore.
4. Application for the appeal without above two enclosures (Medical certificate and DD) and not received in RRB office in time will be summerly rejected.

5. Application for the Appeal should be as per proforma- A should be in candidate's own hand writing and signature.
6. Appeal application received by RRB will sent to PCMD/ SWR. If PCMD is of the opinion that there should be re- medical examination , candidate is required to undergo re- medical examination. The decision of appellate Authority , will be communicated to candidate by RRB/Bengaluru.
7. In case, Railway's decision changes from unfit to fit, DD amount of Rs.1000/- will be returned to the candidate. In all other cases, the DD amount will be forfeited and the candidates will not have any claim on the same.
8. After this appeal no further chance will be given for medical examination.
